The SAAA is proud to announce that, in collaboration with the **Accounting Education** journal, the SAAA T&L conference includes a call for papers for the special issue of *Accounting Education in Africa* (refer to separate call for papers: <http://explore.tandfonline.com/cfp/bes/raed-africa>). **Dr Alan Sangster** (editor, AE) has been invited by the SAAA Exco to attend this conference.

This 2nd call for papers for the SAAA T&L conference calls for abstracts and/or papers in **Accounting Education**, to be submitted to **three tracks**, as follows:

- Track 1: “Show and tell” postcards
- Track 2: Paper for conference proceedings
- Track 3: Paper submission to special issue of AE journal

Note: researchers may decide to submit a full paper to the conference BUT to also submit the paper directly after the conference to any other journal. Such a submission will be included in Track 1 (i.e. not reviewed) and does not form part of the conference proceedings.

Please read the **authors guidelines** included below, and refer to the table on the next page for responses to Frequently Asked Questions.

Author Guidelines

1. **Abstract submissions** should include the title, the authors details and the abstract of not more than 400 words under the following headings:
 - Orientation
 - Purpose of the research
 - Research method or approach
 - Findings
 - Practical implications
 - Limitations
 - Contribution of value
2. **Papers for conference proceedings** should be limited to 5000 – 8000 words including the reference list, with an abstract of between 150 and 250 words and 6-8 keywords.
 - Paper heading should be Arial 14 with text Arial 12 using 1.5 spacing throughout the document. The headings in the paper for the different sub-sections such as abstract and introduction should be in caps and bold with any further headings only in bold.
 - There should be no numbering for the headings.
 - All references should use the Harvard reference method.
 - 2.5cm margins should be used on all sides.
 - Paper submissions must include a cover page and the paper. The cover page should be a *separate* file that includes the title of the paper, the name and surname of the authors and the respective university the authors are affiliated to with the email address of the corresponding author. The paper should include the title of the paper, the abstract with and the details of the paper but should not have any reference to the authors.
3. **Papers for Special Issue of AE Journal:** refer to the separate call for papers: <http://explore.tandfonline.com/cfp/bes/raed-africa> and the instructions to authors: <http://www.tandfonline.com/action/authorSubmission?journalCode=RAED&page=instructions#.V17C67t95dg>.

Papers or abstracts that do not comply with the required criteria will not be considered. Authors are allowed a maximum of 2-3 papers per person for the conference.
