POSTER PRESENTATIONS -

Visual displays (in the form of posters) where poster presenters explain their teaching innovations, challenges, or methods in a summarised and structured manner (Purpose, Approach, Findings, and Impact). Attendees walk around and engage with the poster presenters at their own pace.

Poster Presentation Guidelines: We invite submissions for poster presentations that align with the theme of the event. The poster presentations should address innovations, challenges, and effective strategies in accountancy education.

Submission Guidelines:

- Posters should be submitted in PDF format.
- Include a brief explanation (up to 300 words) of the content and objectives of the poster.
- The PDF should be formatted for A1 size (594mm x 841mm) and should be clearly readable.
- Ensure the content is structured to cover **Purpose**, **Approach**, **Findings**, and **Impact on Teaching and Learning**.

SHOW AND TELL INTERACTIVE SESSIONS

A *dynamic* and *hands-on* segment. It involves live demonstrations where presenters physically show how a teaching tool, method, or technology works in real-time. The "tell" part involves discussing the background, purpose, and results of the innovation as it is demonstrated.

Presentations should focus on:

- **Brief Overview (5 minutes):** Explain the tool or method, its purpose, and how it aligns with improving teaching and learning outcomes in accounting education.
- **Demonstration (10 minutes):** Provide a live or video demonstration showcasing the tool/method. Highlight any specific challenges and solutions that arose during implementation.
- **Engagement (5 minutes):** Engage the audience with a brief Q&A session to discuss possible adaptations or improvements for various educational contexts.

Submission Guidelines:

- Participants should submit a brief abstract (up to 200 words) outlining their show-and-tell topic.
- All submissions must include any necessary materials for the live demonstration (e.g., video files, URLs, or digital handouts).
